**The A487 Trunk Road (Aberarth,
Ceredigion) (Temporary Traffic
Restrictions & Prohibition) Order
2012**

Made 8 May 2012

Coming into force 18 May 2012

The Welsh Ministers, being the traffic authority for the relevant length of the Fishguard – Bangor Trunk Road (A487) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984⁽¹⁾ and of all other enabling powers⁽²⁾, make this Order.

1. This Order comes into force on 18 May 2012 and its title is The A487 Trunk Road (Aberarth, Ceredigion) (Temporary Traffic Restrictions & Prohibition) Order 2012.

2.—(1) In this Order:

“the length of the trunk road” (*“y darn o’r gefnffordd”*) means the length of the A487 trunk road at Aberarth in the County of Ceredigion, that extends from a point 670 metres north-east of the centre-point of its junction with the B4577 to a point 2,180 metres south west of the centre-point of the said junction;

(2) By virtue of S.I. 1999/672, article 2 and Schedule 1, and paragraph 30 of Schedule 11 to the Government of Wales Act 2006, these powers are now exercisable by the Welsh Ministers in relation to Wales.

“works period” (*“cyfnod y gwaith”*) means the period commencing at 07:30 hours on 18 May 2012 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

3. Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

4. Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

6. Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 5 is in operation.

7. The provisions of articles 3, 4, 5 and 6 apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.

8. The provisions of “The A487 Trunk Road (Aberarth, Ceredigion) (30mph and 40 mph Speed limits) Order 2003”⁽¹⁾ are hereby suspended in respect of the length of the trunk road specified in Article 2 during such times as the restrictions specified in Articles 3, 4 and 5 are in operation.

9. The maximum duration of this Order shall be 6 months.
