EXPLANATORY NOTE

Mae'r Gorchymyn hwn yn rhoi effaith i Ran 3 o Fesur Plant a Theuluoedd (Cymru) 2010 ("Mesur 2010") mewn perthynas â dwy set bellach o ardaloedd awdurdod lleol (ac eithrio rhan o adran 58(6)).

This Order brings into effect Part 3 of the Children and Families (Wales) Measure 2010 ("the 2010 Measure") in relation to two further sets of local authority areas (with the exception of part of section 58(6)).

Mae hefyd yn cychwyn rhai pwerau i wneud rheoliadau mewn perthynas â phob rhan o Gymru lle nad ydynt eisoes wedi cychwyn. Mae Rhan 3 (ac eithrio adran 58(6)) eisoes wedi cael ei dwyn i rym gan Orchymyn Mesur Plant a Theuluoedd (Cymru) 2010 (Cychwyn) 2010, ond dim ond mewn perthynas ag ardaloedd awdurdod lleol penodedig, sef Merthyr Tudful, Casnewydd, Rhondda Cynon Taf a Wrexham.

It also commences certain regulation making powers in relation to all parts of Wales where they are not already in force. Part 3 (except part of section 58(6)) has already been brought into force by the Children and Families (Wales) Measure 2010 (Commencement) Order 2010, but only in relation to specified local authority areas, namely Merthyr Tydfil, Newport, Rhondda Cynon Taff and Wrexham.

Mae erthygl 2 o'r Gorchymyn hwn yn cychwyn y darpariaethau yn Atodlen 1. Mae'r darpariaethau'n rhoi pŵer i Weinidogion Cymru i wneud rheoliadau penodol i roi effaith i Ran 3 o'r Mesur ac mae'n cael eu dwyn i rym ar y diwrnod ar ôl i'r Gorchymyn hwn gael ei wneud. Effaith erthygl 2 yw dwyn y pwerau hyn i rym mewn perthynas ag ardaloedd lle nad yw'r pwerau hynny eisoes wedi cychwyn.

Article 2 of this Order commences the provisions in Schedule 1. The provisions give the Welsh Ministers power to make specific regulations to give effect to Part 3 of the Measure and are brought into force on the day after this Order is made. The effect of article 2 is to bring these powers into force in relation to areas in which the powers have not already been commenced.

Mae erthygl 3 a 4 yn cychwyn y darpariaethau a restrir yn Atodlen 2. Mae'r darpariaethau yn cael eu dwyn i rym mewn perthynas ag ardaloedd awdurdod lleol Caerdydd a Bro Morgannwg ar 28 Chwefror 2012 ac mewn perthynas ag ardaloedd awdurdod lleol Sir Gaerfyrddin, Ceredigion, Sir Benfro a Phowys ar 31 Mawrth 2012. Mae'r darpariaethau yn gosod dyletswydd ar awdurdodau lleol i sefydlu un neu ragor o dimau integredig cymorth i deuluoedd yn eu hardal. Rhaid i Fwrdd Iechyd Lleol y mae ei ardal yn cyfateb i ardal awdurdod lleol gymryd rhan wrth sefydlu'r tîm. Mae adran 58 yn nodi'r mathau o achosion a allai gael eu hatgyfeirio at dîm integredig cymorth i deuluoedd ("ICiD") ac mae adran 58(6) yn nodi'r categorïau o oedolion a all fod yn destun atgyfeiriad teulu. Dim ond paragraff (a) o adran 58(6) sydd wedi ei gychwyn, felly dim ond atgyfeiriadau mewn perthynas â theuluoedd lle y mae rhiant yn ddiwyddol ar alcohol neu gyffuriau sy'n gallu cael eu derbyn gan dîm ICiD. Mae adrannau 61 a 62 yn darparu ar gyfer sefydlu byrddau ICiD i arolygu timau ICiD.

Mae erthygl 5 yn cychwyn adran 12 o Fesur 2010 ar 31 Ionawr 2012. Mae adran 12 yn ymwneud â phlant yn cymryd rhan ym mhenderfyniadau awdurdod lleol.

Articles 3 and 4 commence the provisions listed in Schedule 2. The provisions are brought into force in relation to the local authority areas of Cardiff and the Vale of Glamorgan on 28 February 2012 and in relation to the local authority areas of Carmarthen, Ceredigion, Pembrokeshire and Powys on 31 March 2012. The provisions place a duty on local authorities to establish one or more integrated family support ("IFS") teams in their area. A Local Health Board whose area corresponds to the area of a local authority must participate in the establishment of the team. Section 58 sets out the kinds of cases that can be referred to an IFS team and section 58(6) sets out categories of adults who may be subject to a family referral. Only paragraph (a) of section 58(6) is commenced, therefore an IFS team is only able to receive referrals in relation to families where a parent is dependent on alcohol or drugs. Sections 61 and 62 provide for the establishment of IFS boards to oversee the IFS teams.

Article 5 commences section 12 of the 2010 Measure on 31 January 2012. Section 12 concerns the participation of children in local authority decision making.

Title and Interpretation
