Mae erthygl 2 o'r Gorchymyn hwn yn pennu bod adran 42 o Ddeddf 2010, i'r graddau nad yw eisoes wedi ei chychwyn a dim ond mewn perthynas ag ymgymerwyr carthffosiaeth y mae eu hardaloedd yn gyfan gwbl neu'n bennaf yng Nghymru, yn dod i rym ar 1 Hydref 2012.

Mae adran 42 o Ddeddf 2010 yn mewnosod adran 106B yn Neddf y Diwydiant Dŵr 1991 ("Deddf 1991"). Mae adran 106B yn darparu mai dim ond os yw'r amodau a nodir yn adran 106B(2) a (3) o'r Ddeddf honno wedi eu bodloni y caiff person arfer yr hawl, o dan adran 106(1) o Ddeddf 1991, i gael ei ddraenau neu ei garthffosydd i ymgysylltu â charthffosydd cyhoeddus. Mae'r amodau hyn yn cynnwys gofyniad i'r person, cyn adeiladu carthffos neu draen ochrol, ymrwymo mewn cytundeb gyda'r ymgymerwr carthffosiaeth perthnasol o dan adran 104 o Ddeddf 1991 i fabwysiadu'r garthffos neu'r draen ochrol.

Mae adran 106B o Ddeddf 1991 hefyd yn galluogi Gweinidogion Cymru i gyhoeddi safonau (mewn perthynas ag ymgymerwyr carthffosiaeth y mae eu hardaloedd yn gyfan gwbl neu'n bennaf yng Nghymru) ar gyfer dylunio ac adeiladu carthffosydd a draenau ochrol. The Flood and Water Management
Act 2010 (Commencement No.8

EXPLANATORY NOTE

(This note is not part of the Order)

This Order brings into force provisions of the Flood and Water Management Act 2010 ("the 2010 Act").

Article 2 of this Order specifies that section 42 of the 2010 Act, to the extent not already commenced and in relation to sewerage undertakers whose areas are wholly or mainly in Wales comes into force on 1 October 2012.

Section 42 of the 2010 Act inserts section 106B into the Water Industry Act 1991 ("the 1991 Act"). Section 106B provides that a person may only exercise the right, under section 106(1) of the 1991 Act, to have his drains or sewers communicate with public sewers only if the conditions set out in section 106B(2) and (3) of that Act have been satisfied. These conditions include a requirement for the person to, prior to the construction of a sewer or lateral drain, enter into an agreement with the relevant sewerage undertaker under section 104 of the 1991 Act for the adoption of the sewer or lateral drain.

Section 106B of the 1991 Act also enables the Welsh Ministers to publish standards (in relation to sewerage undertakers whose areas are wholly or mainly in Wales) for design and construction of sewers and lateral drains. All adoption agreements under section 104 of the 1991 Act (pursuant to section 106B of that Act) must include any relevant standards, or depart from them with the express consent of the parties to the

1. The title of this Order is the Flood and Water Management Act 2010 (Commencement No.8 and Transitional Provisions) Order 2012.

Provision coming into force on 1 October 2012

2.—(1) Section 42 of the Flood and Water Management Act 2010, to the extent not already commenced, comes into force on 1 October 2012 in relation to sewerage undertakers whose areas are wholly or mainly in Wales.

(2) But article 2(1) is subject to article 3.

Transitional Provisions

3.—(1) In this article—

"the 1984 Act" ("*Deddf 1984*") means the Building Act 1984(2);

ystyr "planiau llawn" ("*full plans*") yw planiau sydd wedi eu hadneuo gydag awdurdod lleol at ddibenion adran 16 o Ddeddf 1984 ac yn unol â rheoliadau 12(2)(b) a 14 o Reoliadau 2010;

ystyr "Rheoliadau 2010" ("*the 2010 Regulations*") yw Rheoliadau Adeiladu 2010(3);

ystyr "tystysgrif planiau" ("*plans certificate*") yw tystysgrif a roddir o dan adran 50 o Ddeddf 1984.

(2) Pan fo carthffos neu ddraen ochrol yn gysylltiedig â gwaith adeiladu—

(a) pan fo hysbysiad adeiladu, hysbysiad cychwynnol, tystysgrif planiau, hysbysiad diwygio neu hysbysiad corff cyhoeddus wedi ei roi i awdurdod lleol neu pan fo planiau llawn wedi eu hadneuo gydag awdurdod lleol, a hynny cyn 1 Hydref 2012; a

(b) pan fo'r gwaith wedi ei ddechrau cyn 1 Hydref 2013,

yna mae adran 106B(4) o Ddeddf 1991 yn gymwys fel pe bai'r cyfeiriad yn adran 106B(4)(a) o Ddeddf 1991 at "standards published by the Minister" a'r cyfeiriad yn adran 106B(4)(b) o Ddeddf 1991 at "those standards" yn gyfeiriadau at yr hysbysiad, y dystysgrif neu'r planiau sy'n berthnasol.

"the 1991 Act ("*Deddf 1991*") means the Water Industry Act 1991(1);

"the 2010 Regulations ("*Rheoliadau 2010*") means the Building Regulations 2010(2);

"amendment notice" ("*hysbysiad diwygio*") means a notice given under section 51A of the 1984 Act;

"building" ("*adeilad*") has the meaning given in regulation 3(1) of the 2010 Regulations;

"building notice" ("*hysbysiad adeiladu*") means a notice given under regulations 12(2)(a) and 13 of the 2010 Regulations;

"building work" ("*gwaith adeiladu*") has the meaning given in regulation 3(1) of the 2010 Regulations;

"full plans" ("*planiau llawn*") means plans deposited with a local authority for the purposes of section 16 of the 1984 Act in accordance with regulations 12(2)(b) and 14 of the 2010 Regulations;

"initial notice" ("*hysbysiad cychwynnol*") means a notice given under section 47 of the 1984 Act;

"lateral drain" ("*draen ochrol*") has the meaning given in section 219(1) of the 1991 Act;

"local authority" ("*awdurdod lleol*") has the meaning in section 126 of the 1984 Act;

"plans certificate" ("*tystysgrif planiau*") means a certificate given under section 50 of the 1984 Act;

"public body's notice" ("*hysbysiad corff cyhoeddus*") means a notice given under section 54 of the 1984 Act;

"sewer" ("*carthffos*") has the meaning given in section 219(1) of the 1991 Act.

(2) Where a sewer or lateral drain is connected with building work where—

(a) before 1 October 2012 a building notice, an initial notice, a plans certificate, an amendment notice or a public body's notice has been given to, or full plans deposited with, a local authority, and

(b) the work is started before 1 October 2013,

then section 106B(4) of the 1991 Act applies as if the reference in section 106B(4)(a) of the 1991 Act to the "standards published by the Minister" and the reference in section 106B(4)(b) of the 1991 Act to "those standards" were references to the relevant notice, certificate or plans.

(3) Section 106B(4) of the 1991 Act does not apply to a sewer or lateral drain that is connected exclusively with buildings or extensions in relation to work which may be started without the requirement under the 2010 Regulations for a building notice, an initial notice, a plans certificate, an amendment notice or a public body's notice to be given to a local authority, or full plans to be deposited with a local authority.

(4) Article 3(3) does not apply after 1 October 2013 except to a sewer or lateral drain which is connected with buildings or extensions for which work has started before that date.
