Mae'r Gorchymyn hwn, sy'n gymwys o ran Cymru a rhanbarth glannau Cymru, yn dwyn i rym ddarpariaethau penodol o Ddeddf y Môr a Mynediad i'r Arfordir 2009 ("Deddf 2009").

Mae erthygl 2 yn dwyn i rym Bennod 1 o Ran 5 o Ddeddf 2009 i'r graddau y mae'n ymwneud â pharthau cadwraeth morol yng Nghymru (adrannau 116 i 128 a 134 i 147) a Phennod 2 o'r Rhan honno sy'n ymwneud â safleoedd cadwraeth eraill (adran 148). Mae erthygl 2 yn dwyn i rym yr Atodlenni cysylltiedig i Ran 5 o Ddeddf 2009 gan gynnwys diwygiadau canlyniadol, darpariaethau trosiannol a diddymiadau.

Mae erthygl 3 yn dirymu is-ddeddfwriaeth o ganlyniad i gychwyn Rhan 5 o Ddeddf 2009.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order, which applies in relation to Wales and the Welsh inshore region, brings into force certain provisions of the Marine and Coastal Access Act 2009 ("the 2009 Act").

Article 2 brings into force Chapter 1 of Part 5 of the 2009 Act so far as relating to marine conservation zones in Wales (sections 116 to 128 and 134 to 147) and Chapter 2 of that Part relating to other conservation sites (section 148). Article 2 brings into force the associated Schedules to Part 5 of the 2009 Act including consequential amendments, transitional provisions and repeals.

Article 3 makes a revocation of subordinate legislation consequential to the commencement of Part 5 of the 2009 Act.

Mae Gweinidogion Cymru, drwy arfer y pwerau a roddwyd gan adrannau 316(1)(b) a (2) a 324(3), (4), (5) a (6)(a) a (b) o Ddeddf y Môr a Mynediad i'r Arfordir 2009(1), yn gwneud y Gorchymyn a ganlyn.

The Welsh Ministers, in exercise of the powers conferred by sections 316(1)(b) and (2) and 324(3), (4), (5) and (6)(a) and (b) of the Marine and Coastal Access Act 2009(1), make the following Order.

**Enwi, cychwyn, cymhwyso a dehongli**

**Title, commencement, application and interpretation**

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Deddf y Môr a Mynediad i'r Arfordir 2009 (Cychwyn a Darpariaethau Canlyniadol) (Cymru) 2014.

1.—(1) The title of this Order is the Marine and Coastal Access Act 2009 (Commencement and Consequential Provisions) (Wales) Order 2014.

(2) Daw'r Gorchymyn hwn i rym ar 12 Rhagfyr 2014.

(2) This Order comes into force on 12 December 2014.

(3) Mae'r Gorchymyn hwn yn gymwys o ran Cymru a rhanbarth glannau Cymru.

(3) This Order applies in relation to Wales and the Welsh inshore region.

(4) Yn y Gorchymyn hwn mae i "rhanbarth glannau Cymru" yr ystyr a roddir i "Welsh inshore region" gan adran 322(1) o Ddeddf y Môr a Mynediad i'r Arfordir 2009.

(4) In this Order the "Welsh inshore region" ("rhanbarth glannau Cymru") has the meaning given by section 322(1) of the Marine and Coastal Access Act 2009.

**Appointed day**

2. 12 Rhagfyr 2014 yw'r diwrnod penodedig ar gyfer dwyn i rym y darpariaethau a ganlyn o Ddeddf y Môr a Mynediad i'r Arfordir 2009—

2. 12 December 2014 is the day appointed for the coming into force of the following provisions of the Marine and Coastal Access Act 2009—

- (a) adrannau 116 i 128 (dynodi parthau cadwraeth morol; dyletswyddau sy'n ymwneud â rhwydwaith cadwraeth a dyletswyddau awdurdodau cyhoeddus);
- (b) adrannau 134 i 148 (gorchmynion ar gyfer gwarchod parthau cadwraeth morol yng Nghymru; gwrandawiaidau; troseddau; cosbau ariannol penodedig; darpariaethau amrywiol ac atodol; a safleoedd cadwraeth eraill) ac Atodlenni 10 (darpariaethau pellach ynghylch cosbau ariannol penodedig o dan adran 142), 11 (diwygiadau canlyniadol sy'n ymwneud â pharthau cadwraeth morol), 12 (darpariaeth drosiannol sy'n ymwneud â pharthau cadwraeth morol) a 13 (ffiniau morol safleoedd o ddiddordeb gwyddonol arbennig a gwarchodfeydd natur cenedlaethol); ac
- (c) Rhan 3 (gwarchod natur) o Atodlen 22 (diddymiadau) ac adran 321 (diddymiadau) i'r graddau y mae'n ymwneud â'r Rhan honno.
- (a) sections 116 to 128 (designation of marine conservation zones; duties relating to the conservation network and duties of public authorities);
- (b) sections 134 to 148 (orders for the protection of marine conservation zones in Wales; hearings; offences; fixed monetary penalties; miscellaneous and supplementary provisions; and other conservation sites) and Schedules 10 (further provisions about fixed money penalties under section 142), 11 (consequential amendments relating to MCZs), 12 (transitional provision relating to MCZs) and 13 (marine boundaries of SSSIs and national nature reserves); and
- (c) Part 3 (nature conservation) of Schedule 22 (repeals) and section 321 (repeals) so far as relating to that Part.

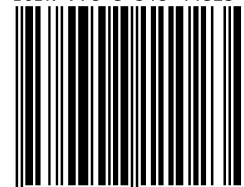
