6. No other additions have been made to the honey except...
7. It must, as far as possible, be free from organic...
8. It must not— (a) have any foreign tastes or odours;...
9. Paragraph 8 does not apply to baker’s honey.
10. No pollen or constituent particular to honey may be removed...
11. Paragraph 10 does not apply to filtered honey.
