Hwn yw'r pedwerydd Gorchymyn Cychwyn a wneir gan Weinidogion Cymru o dan Ddeddf Rheoleiddio ac Arolygu Gofal Cymdeithasol (Cymru) 2016 ("y Ddeddf"). Mae'n cychwyn adran 56(1) o'r Ddeddf, i'r graddau y mae'n mewnosod adran 144A yn Neddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014 ("Deddf 2014"), ac adran 56(2) o'r Ddeddf (sy'n diwygio adran 196(6) o Ddeddf 2014). Y dyddiad cychwyn yw 4 Medi 2017.

Mae adran 144A o Ddeddf 2014 yn gwneud darpariaeth mewn perthynas ag adroddiadau blynyddol gan awdurdodau lleol ynghylch arfer eu swyddogaethau gwasanaethau cymdeithasol, gan gynnwys darpariaeth mewn perthynas â chynnwys a ffurf yr adroddiadau hynny.

Mae adran 56(2) o'r Ddeddf yn diwygio adran 196(6) o Ddeddf 2014 fel bod y rheoliadau cyntaf a wneir o dan adran 144A(2)(b) o Ddeddf 2014 yn ddarostyngedig i'r weithdrefn gadarnhaol. Gall rheoliadau o dan adran 144A(2)(b) ragnodi gwybodaeth arall y mae rhaid ei chynnwys mewn adroddiadau blynyddol awdurdodau lleol.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This is the fourth Commencement Order made by the Welsh Ministers under the Regulation and Inspection of Social Care (Wales) Act 2016 ("the Act"). It commences section 56(1) of the Act, in so far as it inserts section 144A into the Social Services and Well-being (Wales) Act 2014 ("the 2014 Act"), and section 56(2) of the Act (which amends section 196(6) of the 2014 Act). The commencement date is 4 September 2017.

Section 144A of the 2014 Act makes provision in relation to annual reports by local authorities about the exercise of their social services functions, including provision in relation to the content and form of those reports.

Section 56(2) of the Act amends section 196(6) of the 2014 Act so that the first regulations made under section 144A(2)(b) of the 2014 Act are subject to the affirmative procedure. Regulations under section 144A(2)(b) can prescribe other information which must be included in local authority annual reports.

1.—(1) Enw'r Gorchymyn hwn yw Gorchymyn Deddf Rheoleiddio ac Arolygu Gofal Cymdeithasol (Cymru) 2016 (Cychwyn Rhif 4) 2017.

**Title and interpretation**

1.—(1) The title of this Order is the Regulation and Inspection of Social Care (Wales) Act 2016 (Commencement No. 4) Order 2017.

(2) In this Order—

“the Act” (“*y Ddeddf*”) means the Regulation and Inspection of Social Care (Wales) Act 2016;

“the 2014 Act” (“*Deddf 2014*”) means the Social Services and Well-being (Wales) Act 2014(2).
