Mae'r Rheoliadau hynny'n gosod rhwymedigaeth ar gynhyrchwyr i adennill ac ailgylchu gwastraff deunydd pacio er mwyn cyrraedd y targedau adennill ac ailgylchu a nodir yn Erthygl 6(1) o Gyfarwyddeb 94/62/EC Senedd Ewrop a'r Cyngor ar ddeunydd pacio a gwastraff deunydd pacio (OJ Rhif L 365, 31.12.94, t. 10).

Mae'r Rheoliadau hyn yn rhoi targedau ailgylchu ar gyfer cynhyrchwyr yn lle targedau adennill ac ailgylchu'r UE. Maent hefyd yn amrywio'r targedau ailgylchu ar gyfer deunyddiau penodol i gynhyrchwyr sydd o dan rwymedigaeth ar gyfer papur, plastig, gwydr, alwminiwm, dur a phren yn ogystal â'r targed aildoddi penodol ar gyfer gwydr. Mae'r dyraniad ailgylchu ar gyfer cynhyrchwyr bach ar gyfer 2018 i 2020 wedi ei newid ar gyfer 2021 a 2022.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal Asesiadau Effaith Rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn. EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Producer Responsibility Obligations (Packaging Waste) Regulations 2007 (S.I. 2007/871) in relation to Wales. Those Regulations impose on producers the obligation to recover and recycle packaging waste in order to attain the recovery and recycling targets set out in Article 6(1) of European Parliament and Council Directive 94/62/EC on packaging and packaging waste (OJ No L 365, 31.12.94, p. 10).

These Regulations replace the EU recovery and recycling targets with recycling targets on producers. They also vary the material specific recycling targets on obligated producers for paper, plastic, glass, aluminium, steel and wood as well as the specific remelt target for glass. The recycling allocation for small producers for 2018 to 2020 is changed for 2021 and 2022.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. The Welsh Ministers make these Regulations in exercise of the powers conferred by sections 93(1) and (8) and 94(1)(b), (c) and (d) and (7) of the Environment Act 1995 (“the Act”)(1).

The Welsh Ministers have consulted in accordance with section 93(2) of the Act and are satisfied as to the matters specified in section 93(6).

Title, commencement and application

1.—(1) The title of these Regulations is the Producer Responsibility Obligations (Packaging Waste) (Amendment) (Wales) Regulations 2020 and they come into force on 1 January 2021.

(2) These Regulations apply in relation to Wales.

Diwygio Rheoliadau Rhwymedigaethau Cyfrifoldeb Cynhyrchwyr (Gwastraff Deunydd Pacio) 2007

2.—(1) Mae Rheoliadau Rhwymedigaethau Cyfrifoldeb Cynhyrchwyr (Gwastraff Deunydd Pacio) 2007(1) wedi eu diwygio fel a ganlyn.

(3) Yn rheoliad 2(2)—

- (a) hepgorer y diffiniad o “energy recovery”;
- (b) yn y diffiniadau o “PERN” a “PRN”, yn lle “recovery” rhodder “recycling”;
- (c) yn y diffiniad o “producer responsibility obligations” hepgorer “recovery and”;
- (d) yn y diffiniad o “recovery” hepgorer y geiriau o “and for the purposes of” hyd at y diwedd;
- (e) hepgorer y diffiniad o “recovery and recycling obligations”;
- (f) yn lle’r diffiniad o “recycling obligations” rhodder—

““recycling obligations” has the meaning given in regulation 4(4)(b);”.

(4) Yn rheoliad 4(4)(b)(i) hepgorer “recover and”.

(5) Yn rheoliad 7(4)(ca)(i)(aa)—

Amendment of Producer Responsibility Obligations (Packaging Waste) Regulations 2007

2.—(1) The Producer Responsibility Obligations (Packaging Waste) Regulations 2007(1) are amended as follows.

(2) In these Regulations, for “recovery and recycling obligations” in every place that it occurs, except for the definition of that expression in regulation 2(2), substitute “recycling obligations”.

(3) In regulation 2(2)—

- (a) omit the definition of “energy recovery”;
- (b) in the definitions of “PERN” and “PRN”, for “recovery” substitute “recycling”;
- (c) in the definition of “producer responsibility obligations” omit “recovery and”;
- (d) in the definition of “recovery” omit the words from “and for the purposes of” to the end;
- (e) omit the definition of “recovery and recycling obligations”;
- (f) for the definition of “recycling obligations” substitute—

““recycling obligations” has the meaning given in regulation 4(4)(b);”.

(4) In regulation 4(4)(b)(i) omit “recover and”.

(5) In regulation 7(4)(ca)(i)(aa)—

- (a) for “recover” substitute “recycle”;
- (b) omit the words from “and of this” to the end.

(6) In regulation 16(3), for “recover”, in every place that it occurs, substitute “recycle”.

(7) In regulation 20(3) omit “respectively for recovery and”.

(8) In regulation 22(2)—

- (a) in sub-paragraph (a) omit “respectively for recovery and”;
- (b) in sub-paragraph (c) omit “recover and”.

(9) In regulation 24—

- (a) in paragraph (1)(a)(i), for “recovery” substitute “recycling”;
- (b) in paragraph (2) for “recovery”, in both places it occurs, substitute “recycling”.

“1A.—(1) For the purposes of paragraph 1(1)(a), where $\sum Q$ is greater than $\sum Z$, a producer’s obligation is to recycle an amount of packaging waste equal to $\sum Q$.
- (2) In this paragraph—
 - (a) “ $\sum Q$ ” means the sum of Q, as calculated in accordance with paragraph 3(3), for each recyclable material handled by the producer in the preceding year and for each class of producer to which the producer belongs;
 - (b) “ $\sum Z$ ” means the sum of Z, as calculated in accordance with paragraph 3(1), for each class of producer to which the producer belongs.”;
 - (d) in paragraph 3—
 - (i) in sub-paragraph (1)—
 - (aa) for “recovered”, substitute “recycled”;
 - (bb) in the definition of “X”, for “recovery” substitute “recycling”;

(12) In Schedule 7, in paragraph 2 omit subparagraph (c).
