Hwn yw'r pedwerydd gorchymyn cychwyn a wnaed gan Weinidogion Cymru o dan Ddeddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 (“Deddf 2021”).

Mae erthygl 2 o'r Gorchymyn hwn yn dwyn y darpariaethau a ganlyn o Ddeddf 2021 i rym ar 17 Tachwedd 2021—

- adran 19 (cymhwysiad person i gael ei ethol a dal swydd fel aelod o awdurdod lleol yng Nghymru);
- adran 20 (anghymhwysiad person rhag cael ei ethol a bod yn aelod o awdurdod lleol);
- adran 21 (anghymhwysiad aelod o awdurdod lleol yng Nghymru rhag cael ei benodi i swydd daledig);
- paragraffau 1(3) i 1(5), 1(7), 1(9), 5 a 13 o Atodlen 2 (mân ddiwygiadau a diwygiadau canlyniadol mewn perthynas ag etholiadau).

EXPLANATORY NOTE

(This note is not part of the Order)

This is the fourth commencement order made by the Welsh Ministers under the Local Government and Elections (Wales) Act 2021 (“the 2021 Act”).

Article 2 of this Order brings the following provisions of the 2021 Act into force on 17 November 2021—

- section 19 (qualification for election and holding office as a member of a local authority in Wales);
- section 20 (disqualification for election and being a member of a local authority);
- section 21 (disqualification of member of a local authority in Wales for appointment to paid office);
- paragraphs 1(3) to 1(5), 1(7), 1(9), 5 and 13 of Schedule 2 (minor and consequential amendments relating to elections).

Mae erthygl 3 yn diwygio erthygl 6 o Orchymyn Deddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 (Cychwyn Rhif 1 a Darpariaeth Arbed) 2021 i hepgor paragraff 2 o Atodlen 6 i Ddeddf 2021 rhag y darpariaethau a ddygir i rym ar 5 Mai 2022. Mae paragraff 2 o Atodlen 6 yn ddarpariaeth drosiannol sy'n ymwneud â chynorthwyr gweithrediaethau awdurdodau lleol nad oes angen ei dwyn i rym gan fod erthygl 2 yn dwyn i rym baragraffau 1(3) ac 1(7) o Atodlen 2.

Mae erthygl 4 yn gwneud darpariaeth drosiannol i sicrhau nad yw'r darpariaethau a restrir ym mharagraff (2) a ddygir i rym gan erthygl 2 ar 17 Tachwedd 2021 ond yn cael effaith mewn perthynas ag etholiad llywodraeth leol a gynhelir ar 5 Mai 2022 neu ar ôl hynny. Mae hyn yn golygu y bydd y darpariaethau perthnasol yn cael effaith at ddibenion y trefniadau paratoadol sydd eu hangen ar gyfer etholiad o'r fath, gan gynnwys penderfynu a yw ymgeisydd yn gymwys i gael ei ethol. Fodd bynnag, ni fydd y darpariaethau a restrir yn erthygl 4(2) yn cael unrhyw effaith at ddibenion unrhyw etholiad llywodraeth leol a gynhelir cyn 5 Mai 2022.

Article 3 amends article 6 of the Local Government and Elections (Wales) Act 2021 (Commencement No. 1 and Saving Provision) Order 2021 to omit paragraph 2 of Schedule 6 to the 2021 Act from the provisions which are brought into force on 5 May 2022. Paragraph 2 of Schedule 6 is a transitional provision relating to assistants to local authority executives which does not need to be brought into force as a consequence of article 2 bringing into force paragraphs 1(3) and 1(7) of Schedule 2.

Article 4 makes transitional provision to ensure that the provisions listed in paragraph (2) which are brought into force by article 2 on 17 November 2021 only have effect in relation to a local government election taking place on or after 5 May 2022. This means that the relevant provisions will be in effect for the purposes of the preparatory arrangements required for such an election, to include determining whether a candidate is qualified to be elected. However, the provisions listed in article 4(2) will have no effect for the purposes of any local government election that may take place before 5 May 2022.

Amendment of the Local Government and Elections (Wales) Act 2021 (Commencement No. 1 and Saving Provision) Order 2021

3.—(1) Article 6 of the Local Government and Elections (Wales) Act 2021 (Commencement No. 1 and Saving Provision) Order 2021(1) is amended as follows.

(2) For paragraph (t) substitute “(t) paragraphs 1, 3 to 5 and 6(1) to (4) of Schedule 6;”.

Transitional provision

4.—(1) Despite the coming into force of the provisions mentioned in paragraph (2) by virtue of article 2, they only have effect in relation to a local government election at which the poll is held on or after 5 May 2022.

(2) The provisions are—

- (a) sections 19 to 21;
- (b) paragraphs 1(3) to 1(5) and 1(7) of Schedule 2.
