Mae'r Rheoliadau hyn yn diwygio adran 85 o Deddf Cefn Gwlad a Hawliau Tramwy 2000 (p. 37). Mae adran 85(1) yn darparu, wrth arfer neu gyflawni unrhyw swyddogaeth mewn perthynas ag ardal o harddwch naturiol eithriadol, neu sy'n effeithio ar ardal o'r fath, bod rhaid i "relevant authority" roi sylw i'r dibenion o gadw a gwella harddwch naturiol yr ardal.

Mae adran 85(2) yn rhestru'r cyrff a'r personau sy'n "relevant authority" ac sydd felly yn ddarostyngedig i'r ddyletswydd a gynhwysir yn adran 85(1). Mae'r rhestr yn cynnwys "any public body", gydag adran 85(3) yn rhestru cyrff sydd wedi eu cynnwys o fewn y term hwn.

Mae'r Rheoliadau hyn yn diwygio adran 85(3) fel bod cyd-bwyllgorau corfforedig a sefydlir drwy reoliadau a wneir o dan Ran 5 o Deddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 (dsc 1) ("y Deddf"), wedi eu cynnwys yn y rhestr o gyrrf cyhoeddus yn adran 85(3). Drwy hyn, mae cyd-bwyllgorau corfforedig yn ddarostyngedig i'r ddyletswydd yn adran 85(1).

The Countryside and Rights of Way
Act 2000 (Meaning of Public Body)
(Wales) Regulations 2021

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

These Regulations amend section 85 of the Countryside and Rights of Way Act 2000 (c. 37). Section 85(1) provides that when exercising or performing any function in relation to, or affecting, an area of outstanding natural beauty a "relevant authority" shall have regard to the purposes of conserving and enhancing the natural beauty of the area.

Section 85(2) lists the bodies and persons who are a "relevant authority" and who are therefore subject to the duty contained in section 85(1). The list includes "any public body", with section 85(3) listing bodies that are included within this term.

These Regulations amend section 85(3) so that corporate joint committees, established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021 (asc 1) ("the Act"), are included in the list of public bodies in section 85(3). This results in corporate joint committees being subject to the duty in section 85(1).

Mae'r Rheoliadau hyn yn gysylltiedig â rheoliadau a oedd yn sefydlu cyd-bwylgorau corfforedig penodol o dan Ran 5 o'r Ddeddf.

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal asesiadau effaith rheoleiddiol mewn perthynas â'r rheoliadau sy'n sefydlu cyd-bwylgorau corfforedig a gorchmynion a rheoliadau cysylltiedig. O ganlyniad, lluniwyd asesiad effaith rheoleiddiol. Gellir cael copi oddi wrth: yr Is-adran Cyllid Strategol Llywodraeth Leol, Llywodraeth Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

These Regulations are connected with regulations which established certain corporate joint committees under Part 5 of the Act.

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to the regulations which establish corporate joint committees and connected orders and regulations. As a result, a regulatory impact assessment has been prepared. A copy can be obtained from the Local Government Strategic Finance Division, Welsh Government, Cathays Park, Cardiff, CF10 3NQ.

accordance with section 174(4) and (5)(l) of that Act.

Title and coming into force

1.—(1) The title of these Regulations is the
Countryside and Rights of Way Act 2000 (Meaning of
Public Body) (Wales) Regulations 2021.

(2) These Regulations come into force on 3
December 2021.

Amendment of section 85 of the Countryside and Rights of Way Act 2000

2. In section 85 (general duty of public bodies etc.) of the Countryside and Rights of Way Act 2000(1), in subsection (3), in the definition of “public body”, at the end insert—

“(e) a corporate joint committee established by regulations made under Part 5 of the Local Government and Elections (Wales) Act 2021;”.
